## **1959 MODEL NATIONALS**

The 28th Annual U. S. National Model Airplane Championships will be held at the Los Alamitos Naval Air Station, Long Beach, Calif., from July 27th through August 2nd. Sal Taibi has agreed to be Contest Director, as he was in 1955 when the Nationals were last held at Los Alamitos. Male contestants will be provided housing and meals aboard the air station at very nominal rates, although they must provide their own sheets and blankets.

Only modelers that register in advance will be allowed to compete in the Nationals. Postmark deadline for entries is July 6th. Official entry blanks are scheduled to be mailed to all AMA members on or about May 1st.

The Nationals will include competition in all categories of model gliders, three age groups in each category. The SSA has provided funds for an award to the best competitor in model glider events at the Nationals, to be administered by AMA. In addition, an SSA Student Membership will form part of the award.

#### NORDIC ELIMINATIONS SET

The Free Flight International Competition Committee of the Academy of Model Aeronautics has outlined the procedures to be used in selecting the U. S. team for the World Championships of A-2 Nor-dic towline gliders. The Champion-ships are to be held in Belgium on August 22-23, 1959.

The three-man U.S. team will be selected by a two-stage elimination procedure. Everyone may compete in the first stage, known as the Local Elimination, but a modeler must be among the top 20 per cent or have a flight total of at least 10 minutes in his Local Elimination to qualify for entry in the next and last stage, the Semi-Final.

Local Eliminations are to be held over the June 13-14 weekend in approximately 25 locations throughout the country: EAST: Boston; Watertown, N. Y.; New York City-Philadelphia; Baltimore; Norfolk, Va.: Miami; Knoxville, Tenn. and Cleve. land. CENTRAL: Bloomington, Ill.; Galesburg, Ill.; Chicago; Detroit;

Minneapolis; Omaha; Kansas City; Wichita; Tulsa; and Dallas Ft. Worth. WEST: Denver; Salt Lake City; Seattle; Marysville, Calif.; Santa Barbara, Calif.; Los Angeles; and Phoenix. If none is scheduled in an area where there is sufficient interest to warrant holding one, a petition to the committee can establish and recognize one in that area. Five flights will be flown, just as is provided in the official competition rules.

Semi-Finals are scheduled for July 4-5 in three locations, expected to be near Baltimore, Md., Kansas City, Mo., and Sacramento, Calif. The top modeler from each Semi-Final will form the U. S. team for the Championships. The Semi-Finals this year will require five flights on each day, thus insuring the selection of consistent modelers, so necessary for top placing in the World Championships. Flying will be by the round system, two hours being allotted for each round, requiring flying during all parts of the day. Modelers who qualify for entry in a Semi-Final must fly in the Semi-Final of their area, as designated by the commit-The western area's eastern tee boundary includes Mont., Wyo., Utah and N. M. The midwestern area's eastern boundary includes Wis., Ind., Ill., Mo., Ark. and La.

### 1959-1960 AMA **RULES CHANGES**

The AMA Contest Board has announced the following changes to the 1957-1958 rules as of Jan. 1, 1959.

Outdoor hand-launched gliders: the number of flights is reduced from 9 to 6; the maximum scored flight duration is reduced to 4 minutes. For indoor gliders, the number of flights permitted will remain at 9.

Proxy flying is specifically prohibited for indoor and outdoor handlaunched glider and radio control glider events.


Key to Events and Scope: TLG-Tow-line Glider: OHLG-Outdoor Hand-launch-ed Glider; IHLG-Indoor Hand-launched (AAA)-state or regional meet Glider: with at least eight competitive events, at least two age classifications in the majority of events and prizes through three or more placings in the majority of events; (AA)—meet with unrestricted entry in which awards are presented through two or more placings; (A)—either a meet with a restricted entry, a meet with unrestricted entry but with token awards, or an organized get-together with no formal competition; (RT)--record trials, no prizes.
